

**CLASS CONSTITUTION**  
Amendments

**I § 5 – Commons Representatives or Class Representatives?**

*As written:*

- Each Commons group within the Class shall designate a single Representative to represent that Commons in the Class Government. A Commons Representative can be recalled or replaced by the members of his or her Commons by motion of that Commons.

*General Amendment:*

- The Class as a whole shall elect nine Representatives to represent the entire Class in the Class Government.

*And change “Commons Representatives” to “Class Representatives” throughout.*

**II § 1 – Should the President vote?**

*As written:*

- The voting members of the Class Government shall be the four Officers (the President, Vice President, Secretary, and Treasurer), and the Commons Representatives. These shall be collectively known as the Class Council.

*General Amendment:*

- *Sec. 1* The voting members of the Class Government shall be the Vice President, Secretary, and Treasurer, and the Commons Representatives. The President may not vote. All Officers and Commons Representatives shall be collectively known as the Class Council.

## II § 2 – Should members of the general Student Body vote?

*As written:*

- Members of the general Student Body of the Class may attend the meetings and partake in the discussion, but do not have voting privileges.

*General Amendment:*

- Members of the general Student Body of the Class may attend the meetings and partake in the discussion, and shall be allowed to vote along with the Officers and Commons Representatives.

## II § 3 – What constitutes a quorum?

*As written:*

- The Class Council shall meet once each week on the day assigned to it. A quorum of three Commons Representatives and two Officers is necessary to conduct official business.

*General Amendment:*

- The Class Council shall meet once each week on the day assigned to it. A quorum of a majority of persons on the Class Council, including at least one Officer, is necessary to conduct official business.

## II § 5 – Who breaks a tie vote?

*As written:*

- In the case of a tie vote, the President shall cast the deciding vote.

*General Amendment:*

- In the case of a tie vote, the outcome shall be determined by a re-vote.

### **III § 8 – Should election results be made public knowledge?**

*As written:*

- The candidates, except for the victor in the election, shall have the right to request the exact numbers of the election results in their respective races. However, this information shall not be released to the general Student Body unless all candidates in that race unanimously agree to release it.

*General Amendment:*

- The results of each Election shall be made available to the general Student Body.

### **III § 9 – Should there be term limits?**

*General Amendment:*

- No person may run for an Office if he has already been elected to that same Office twice previously for a full-year term in an Election of the general Student Body.

### **IV § 5 – Should SGO Officers be allowed to be Class Officers?**

*As written:*

- Persons serving as SGO President, SGO First Vice President, or SGO Second Vice President may not serve as Class Officers at the same time.

*General Amendment I:*

- No person serving as an SGO Officer shall be allowed to serve as Class Officers at the same time.

*General Amendment II:*

- The right of persons serving as an SGO Officer to serve as Class Officers at the same time shall not be denied.
